Re: DFO Proposed Termination of SVIAC Sooke Chinook Enhancement Initiative / Orca Food Security Program (SCEI/OFSP) as outlined in Attachment 1 – Letter to SFAC Victoria on February 3, 2025

Dear Minister Thompson,

As the stewards and custodians of the Sooke Chinook Enhancement Initiative / Orca Food Security Program for the past eight years, the South Vancouver Island Anglers Coalition (SVIAC) with ongoing support from T'Sou-ke First Nation and the Sooke community expresses profound disappointment regarding the Department of Fisheries and Oceans (Department) lack of transparency, lack of engagement, lack of consultation, and lack of formal communication regarding the Departments decision to terminate the highly beneficial and successful SCEI / OFSP in the Sooke Basin.

SVIAC expresses its deep concern and outrage over the:

- 1. Lack of Consultation or Engagement: The Department failed to undertake any formal or informal engagement or consultation with SVIAC regarding its strategy and decision to terminate the SCEI/OFSP. This includes neglecting to analyze or recognize the success of SVIAC's highly regarded project.
- 2. **Absence of Formal Notification**: As of the date of this letter, SVIAC has not received any formal notification from the Department concerning the decision to terminate the SCEI/OFSP.
- 3. **Exclusion of Stakeholders**: The Department's strategy and decision appear to have been finalized and approved without meaningful stakeholder engagement. This includes failing to involve SVIAC, the T'Sou-ke First Nation, or the Sooke community. Instead, the process for inviting comments and feedback was reduced to a mere procedural formality, undermining the integrity of stakeholder collaboration.

SVIAC has provided a detailed response (Attachment 2) to the Department's rationale, and respectfully requests a meeting with you or your staff at your earliest convenience to discuss the following recommendations:

- 1. Formal documentation of the Department's consultation and decision-making process, including supporting data, be provided to SVIAC.
- 2. The Department's strategy be realigned with SVIAC's Sooke River Chinook conservation goals, T'Sou-ke First Nation interests, and ecological benefits be reconsidered.
- 3. SVIAC's SCEI/ OFSP requirements (500,000 smolts) be reinstated in the 2025 IFMP SEP Production Plan for Spring 2026 out planting.
- 4. SVIAC notes that the Department's 2025 IFMP / SEP / Hatchery Production Planning process is currently underway and **time is of the essence** to include SVIAC's SCEI / OFSP in the 2025 Production Plan / IFMP.
- 5. Long term alternative solutions for the Sooke River Chinook recovery be explored to address local resource and ecological concerns while continuing the SCEI/ OFSP.
- 6. The broader consequences on First Nation, local fisheries, local communities and ecosystems be prioritized in future studies and deliberations.
